Liquidity risk management: The Board of Directors of the Company has an overall responsibility and oversight for the management of all the risks, including liquidity risk. The Board of Directors of the Company has constituted the Asset Liability Management Committee, Risk Management Committee, and Investment Committee.

The Asset Liability Management Committee, inter alia, reviews the asset liability profile, risk monitoring system, liquidity risk management, funding and capital planning, profit planning and growth projections, forecasting and analyzing different scenarios and preparation of contingency plans. Further, the Risk Management Committee, inter alia, monitors and measures the risk profile of the Company and oversees the integrated risk management system of the Company. The Company manages liquidity risk by maintaining sufficient cash/treasury surpluses.
